## Grants

The Canterbury Opera Foundation raises money principally through donations. The income from the capital fund is applied as grants to assist extraordinary local opera artists and organisations to succeed in all facets of opera in Canterbury.

Assistance may include funding for requests for travel, courses, tuition, equipment, projects or initiatives.

To qualify individual applicants must have strong ties to Canterbury, and demonstrate extraordinary ability or potential in opera.

The Foundation also supports organisations and artists to supplement their own fundraising activities and will consider underwriting costs of performances and events, but is not a "Key" major funder for individuals or for larger scale performances and events.



#### Guidelines for Grant Applications

- Applications and supporting documentation are to be completed using the application form.
- 2. Applicants must be prepared to make themselves available for an interview as part of the application.
- Applicants will be advised when Trustees will next consider applications. This is usually undertaken at the next quarterly meeting of Trustees.
- 4. Applicants will be notified in writing and successful applicants acknowledge the following conditions will apply.
- 5. All grants are made at the sole discretion of Trustees.
- 6. There is no requirement to make annual grants.
- 7. The grant value is at the sole discretion of the Trustees.
- 8. Applicants are required to sign a declaration.

- 7. The Canterbury Opera Foundation may publicise the grant recipient's name, and the purpose and details of the grant.
- 8. The information provided in the application form to The Canterbury Opera Foundation is true and accurate.
- 9. Applicants are required to sign the declaration.
